WORKING PERMISSION

Whereas, the Stage-I (In-Principle) Approval was granted by the Central Govt under Forest (Conservation) Act, 1980 vide MoEFCC's Letter No.3-SK-B 033/2013-SHI/2359-60 dated the 3rd November 2015 for diversion of 0.3440 Ha (Khasmal) of Forest Land for Construction of Link Road (3 Km) from Kolthang Maney Dara to Jogi Dara Km 1st to Km 3rd in South District of Sikkim by Road & Bridges Department and subsequently communicated by this office vide Letter No.1539/FCA/FEWMD/62-64 dated 17-04-2015 for compliance of conditions by the User agency.

Whereas, the User agency has fulfilled the compliance of conditions by furnishing the requisite documents and releasing the payment towards the cost of the compensatory levies as per the conditions of the Stage-I approval as specified below:-

Whereas, on fulfilment of compliance of conditions by User agency in completeness, the Stage-I (In-principle) Approval issued by the Central Govt under the Forest (Conservation) Act 1980 (FC Act) for the aforesaid project proposal, is deemed to be **Working Permission** for felling of trees and commencement of works in forest land in terms of Para 2(i) of Guidelines for diversion of forest land for non-forest purpose under the Forest (Conservation) Act 1980 - Simplified procedure conveyed by the Ministry vide Letter F. No.11-306/2014-FC (Pt) dated the 28th August 2015.

- Now, therefore, the State Govt is pleased to authorize the Divisional Forest Officer (Territorial), South Division having the jurisdiction over the forest land proposed to be diverted under the Act, to pass an Order for tree cutting and commencement of works in the forest land for a period of one year in terms of Para (ii) of the Guidelines referred to above.
- This Working Permission along with the Stage-I approval and Compliance Report forwarded to the Ministry of Environment Forests & Climate Change, Govt of India, shall be put in the website for public domain in terms of Para 2 (iii) of the Guidelines conveyed by the Ministry in this respect. This is issued within the delegated powers of the State Govt as conveyed by the Ministry with the Guidelines referred to above.
