## CONSULTANCY SERVICE FOR THE PREPARATION OF DETAILED PROJECT REPORT (DPR) FOR THE ESTABLISHMENT OF A WORLD CLASS BIODIVERSITY PARK & ECOTOURISM CENTER AT TENDONG, SOUTH SIKKIM

Forest, Environment and Wildlife Management Department (FEWMD), Government of Sikkim intends to develop a world class Biodiversity Park and Ecotourism Center at a designated area in Tendong, South District of Sikkim. This facility is being established with the objective of protection, conservation, propagation and extension of the state's genetic resources and to utilise the facility for environmental awareness and recreation. Components of the project would include displays of the State's biodiversity in their natural state by setting out natural areas with appropriate demarcation, signage and walkways, international arboretum, series of mini interpretation centers, look-outs, public utilities, mountain biking tracks etc.

FEWMD hereby invites 'Expression of Interest' from eligible reputed Organisations/ Institutions/ Consultancy firms/ Companies and Consortiums for appointment of Consultant(s) preferably with global area of operations (Indian or foreign origin- in India or abroad) and having extensive experience and expertise in the fields of Bio Diversity Park Development, conservation and Ecotourism planning & development for the preparation of a Detailed Project Report (DPR) that will include concept plans, designs and detailed estimates of the Biodiversity Park & Ecotourism Center and providing assistance in subsequent stages of preparation and evaluation of tender documents for execution of approved works and in supervising their implementation and certification after completion of the works thereby developing the Biodiversity Park & Ecotourism Center at Tendong, South Sikkim as a World class State of the art facility in Sikkim for Biodiversity Conservation, knowledge dissemination and ecotourism attraction.
