Invitation for Proposals (IFP) for a study on The Impact of Grazing Restriction on the Ecology of Sikkim and on the Socio-economy of the Pastoral Communities

1. Introduction

The Project Management Unit (PMU) of the Department of Forest, Environment, and Wildlife Management (DFEWM), Sikkim implementing the JICA assisted Sikkim Biodiversity Conservation and Forest Management Project (SBFP) invites proposals, in the annexed format, from qualified organizations for conducting the captioned study as per the details provided hereunder. The overall objective of the SBFP is to strengthen the biodiversity conservation activities and forest management capacity and to improve the livelihood of the local communities. 2. Background to the study

Traditionally, grazing is an important animal husbandry practice in all parts of Sikkim. During the period 1977-92 there has been a marked increase in the livestock population, with a cumulative increase of 66 per cent- the total livestock population, excluding poultry was put at 3.8 lakh¹. The forest lands and the traditional grazing lands (*gouchaaran* and *khasmal*) came under enormous pressure leading to rapid habitat degradation.

In order to reduce the grazing associated degradation, Forest, Environment and Wildlife Management Department (FEWMD) issued a ban on open grazing in reserved forest areas, plantations and near water sources in South and West Districts in 1995 and expanded the ban to all of Sikkim in 1998². Free grazing of domestic livestock has been prohibited in all reserved forests and plantations in the State through this order.

² As for the legal provisions, Section 20(h) of the Sikkim Forests, Water Courses and Road Reserve (Preservation and Protection) Act 1988 prohibits "trespasses or pastures cattle or permits cattle to trespass without a permission in writing"; Wildlife (Protection) Act 1972 prohibits grazing in National Parks but the powers to prohibit or permit grazing in Sanctuary rest with the Chief Wildlife Warden. The Hon'ble High Court of Sikkim has prohibited grazing through an order delivered on 14/05/1999, and the Hon'ble Supreme Court in its WP No 202/95 dated 14/02/2000 has proscribed all forms of consumptive uses in Protected Areas.

Considering the high dependency of the rural population on forest resources, the ban implementation has been a challenging task. The ban was implemented phase-wise and now covers all the reserved forest areas in the State. A recent report³ indicates that grazing pressure in the protected areas and its surrounding reserve forests in West Sikkim district is no longer a serious problem.

The present study is to understand the impact of the grazing restriction on the natural habitats covering the forests, including Protected Areas, alpine grasslands and the traditional grazing lands and to evaluate the impact on the pastoral communities.

3. Objective of the study:

To assess the impact of grazing restrictions on the forests and grasslands and on the socio-economy of graziers in Sikkim.

4. Duration of the study: Two years

5. Domains of impact to be considered:

The grazing restriction impact may cover ecological aspects such as the change in forest cover, the availability of non-timber forest produce (NTFP), the forest fire regime, the forest regeneration, etc. The socio-economic impact may cover the change in livelihood of the pastoral community including change in occupation, shifting of grazing pressure to areas less patrolled, change in livestock management practices, etc.

The area covered shall be the whole of Sikkim.

6. Proposed activities:

- Review the literature on the impacts of grazing or the grazing ban on vegetation and/or socio-economic condition of the local communities in Sikkim.
- To select sites to investigate the impact of the grazing ban on the vegetation, considering the various forest types in Sikkim, including grasslands. In view of the 2012 study in West Sikkim district mentioned earlier, priority for study sites selection may be accorded to the three other districts while at the same time adequately covering west district also.
- Confirm the methodology for determining the impacts/changes in the different attributes studying.
- Study the status of grazing animals (for example, number, their productivity and forms of grazing) and socio-economic status of the local communities in the sites in the past and at present, applying the methodology developed above.
- Determine changes in vegetation cover and composition of species after the implementation of the ban on grazing in the sites, with the aid of satellite images.
- Determine change in habitat condition, hydrology and edaphic factors in the sites.
- Assess the perspective of local communities on the grazing ban and to study the change in livelihood strategies adopted by them.

- Analyze the observed changes in ecosystem and socio-economic status in relation to the grazing ban.
- Assess the grazing issues in the traditional grazing lands.
- Review and analyse the legal issues related to grazing.
- Formulate recommendations for developing a grazing policy for the state.

7. Deliverables

- 1. Inception report in the first month of the Study.
- 2. Quarterly progress reports.
- **3**. Draft Final Report to SBFP for comments at the end of the22ndmonth.
- 4. Final Report to the satisfaction of SBFP at the end of the 24th month.

8. Expected output:

The outcome shall be a robust empirical narrative of the impact of grazing restriction on forests and grasslands in Sikkim and on the socio-economic condition of the local communities in Sikkim, and recommendations for strengthening the positive impacts of grazing restriction and to improve the livelihood security of the local communities. The recommendations shall subsequently form the baseline ideas for formulating a grazing policy for the State.

9. Budget:

The total fund available for this study is Rs. 24,78,110. Payment will be made to the selected consultant in a progressive manner against deliverables. No advance payment shall be made available.

10. Eligibility and team composition

Organizations with excellent track record in environmental studies may submit proposals. The research team shall be composed of a Principal Investigator and a Researcher. The Principal Investigator shall be a PhD with at least 10 years experience in a discipline relevant to the study. The Researcher shall be a Masters Degree holder in a related field and having a minimum of two years experience in a discipline relevant to the study.

11. Selection process

Selection of the consultant shall be based on the evaluation of the proposals received. The decision of the PCCF-cum-Principle Secretary shall be final.

12. Selection Criteria and Scoring Weightage

The following criteria and scoring weightage shall be used in evaluating the proposals received.
