#### **ELIGIBILITY**

#### **Essential Qualifications:**

- b. Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government
- c. Excellent knowledge and skills in computer applications.
- d. Should have attained the age of **21 years**, but should not have exceeded **40 years** as on the date of application.
