- 2. The invitation is to submit a proposal (the bid) for design, engineering, financing, construction & maintenance (two years from the date of operation), training with regard to construction of zip lining at Biodiversity Park, Kitchudumra, South Sikkim.

CHAPTER I: INTRODUCTION

A. <u>Background</u>

The Forest & Environment Department is developing a Biodiversity Park along with eco-tourism activities for the visitors at Kitchudumra, South Sikkim. For the same, one of the activity proposed is establishment of zip lining as a major visitor attraction.

B. Brief particulars of the Project

C. Scope of work

The scope of work will broadly include"

- 1. Survey and geo-technical investigation
- 2. Design, engineering, financing, procurement and construction of zip lining towers and zip lining along with accessories.
- 3. Prepare the drawings and plans and obtain approval from F&ED, at its own cost.
- 4. Acquire necessary permission for commencement of the construction, at its own cost.
- 5. Commence the work, at its own cost, under the full time supervision of technical staff from the firm along with departmental officers and staffs.
- 6. Provide all <u>maintenance requirements for the period of two years</u> including all expenses from the date of obtaining the completion certificate. The training to operate the zip lining is also to be provided successfully prior to obtaining the completion certificate.
- 7. The design should include safeguards against seismic forces as per the guidelines of Bureau of Indian standards on earthquake and also include protection against slides or any damages.
- 8. The work shall be completed within <u>five months</u> from the date of commencement of work under this RFP. In the event of delay in completion of the project, penalty of 0.5% on Project cost per month or part thereof will be levied by the department on the developer awarded the contract.

D. Eligibility of the bidders

- 1. The bidder should be either a company registered under companies Act 1956/2013 or LLP firm under Limited Liability Partnership Act, 2008 or partnership firm under Partnership Act, 1932.
- 2. The bidder should be at least two years old company.
- 3. The company should have minimum audited turnover of Rs. 1 crore in the last financial year.
- 4. The company should have at least 6 ziplines developed that are above 100m and has developed at least 3 projects in similar terrain to Sikkim or any similar works carried in NE states of India and Nepal.
- 5. Preferences shall be given to firms having membership in Adventure Tour Operators Association of India (ATOAI) and/or any of the foreign associations like European Ropes Course Association (ERCA), Professional Ropes Course Association (PRCA).

CHAPTER II

BIDDING PROCESS

A. Brief description of Bidding Process and Instruction to the Bidders.

1. In this process, the bidders are required to submit only one bid. The bid is to be submitted into two (2) parts, viz

Part 1: Technical Bid

Part 2: Financial Bid

2. The bidder is to make payment/ deposit Rs. 10,000/- in the form of NEFT as tender form cost in the following details:

The details of the payment made may be printed out and submit inside along with 'bid security' TDR in Envelope1A (Details of envelopes to be submitted given below in Sealing and Marking of Bids.

- 3. The bidder is required to deposit, a bid security of Rs. 2 lacs only along with the bids, by way of TDR in the name of DFO, Environment & SC, South, Forest & Environment Department, Government of Sikkim. The TDR should be from nationalised bank, refundable not less than 180 days from bid due date, except in the case of the selected bidder whose bid security shall be retained till completion of the work. The selected bidder will have to provide bank guarantee and the validity period of the bid security, shall not be less than 180 days from the bid due date.
- 4. The department, in writing, will request the selected bidder to provide a new valid bid security (TDR) upon expiry of the validity of TDR submitted as bid security in the initial stage.
- 5. The bidders are invited to submit Technical bid and financial bid for the Project. The bids will be basis for evaluation and for eventual contract negotiations, and ultimately, the signature of the contract with the selected bidder.
- 6. The bidders are requested to submit their bids in English language.
- 7. The cost of preparing the bid, including site visit and F&ED office, are not reimbursable and department is not bound to accept any of the bids submitted.

B. Sealing and Marking of Bids.

- 1. Envelope 1 shall be sealed and shall contain Envelope 1A, Envelope 1B, Envelope 1C & Envelope 1D.
- 2. Envelope 1 shall be sealed and clearly bear the identification "Request for Proposal: project name as mentioned" and the name and address of the bidder from the outside cover and contain all the envelopes mentioned in sl. No. 1.
- 3. Envelope 1A shall be sealed and bear the identification "Bid security" and shall contain Bid security Bank guarantee TDR in with a cover letter for bid security. It should also contain printed document related to payment made for cost of tender form apart with Bid security.

- 4. Envelope 1B shall be sealed and bear the identification "Technical Bid" and shall contain all the Annexures viz I, II, III along with drawings and methodology of execution.
- 5. Documents to be submitted for supporting claims in Annexure III should be enclosed in an envelope with identification as "Annexure III" and put inside Technical Bid (Envelope 1B)
- 6. Envelope 1C shall be sealed and bear the identification "Financial Bid" and shall contain Annexure IV along with detailed estimate/ financial forecast.
- 7. The sealed envelope *should reach the following address* within stipulated time.

- 8. If the envelopes are not sealed and marked as instructed above, the department assumes no responsibility for the misplacement or premature opening of the contents of the bid and consequent losses, if any, suffered by the bidder.

- 1. The Bids should be submitted before 3 pm on the bid due date at the address provided above.
- 2. Bids received by the department after the specified time on bid due date shall not be accepted and considered disqualified.

D. <u>Payment</u>

The work is to be completed in five months only. Therefore, payment to the successful bidder shall be made after the completion of the work only

E. Terms and Conditions

- 1. The work shall be supervised full time by the technical staff/ officer of the firm during the construction. The firm shall also take responsibility of the maintenance of the work for 2 years after its operation including the travel cost.
- 2. The firm shall also provide training to carry out ziplining after completion of work.
- 3. No individual/ firm does not accrue any right to claim for any kind of Govt. Jobs whatsoever by the persons involved in the work.
- 4. All persons engaged in the work shall not have any liabilities to the department in the event of any unnatural death, accrued death or any kind of injuries/ illness caused during the course of works.
- 5. The persons/ firm engaged in the work or their legal/natural representatives, successors/heirs shall not have any right and privileges to claims for compensation or appointment on compassionate ground in the unlikely event of unnatural death/accrued death to the department.
- 6. The firm/ organisation/ contractor who is executing the work, shall be held liable for the event of unnatural death, accrued death or any kind of injuries/ illness caused arising out of and in course of his employment. The same shall be implemented during its operation after completion of the work.
- 7. The firm shall ensure good quality work and also ensure use of good quality materials to avoid any casualties/ death to any person or injury to any person. Failure to comply the same and in the event of such casualties or injury be held liable to the executing firm.
