1. (b) EARNEST MONEY

The earnest money by way of demand draft should be enclosed with Tender Document drawn in favour of State Medicinal Plants Board payable at Gangtok at State Bank of India (Deorali Branch) for Rs. 15000/- (Fifteen thousand only).

Earnest Money Deposit shall be released/refunded after completion of supply. No interest shall be paid on the Earnest Money Deposit/ Security Deposit.

- 2. PRICE: Rate/ rates quoted should be F.O.R. Destination: State Medicinal Plants Board Office, Gangtok.
- 3. SPECIFICATION: Rate/ rates quoted should be strictly as per the unit and specification mentioned in the NIT.
- 4. INSURANCE: Rate/rates quoted, should be inclusive of the transit insurance upto the destination and shall be at the cost of the bidder.
